***BRED BY EXHIBITOR (BBE) Class Eligibility (Revised 9/02)***

Effective 9/02, the Bred By Exhibitor Class shall be for dogs that are:

- Six months of age or older as of the first day of the show;
- Not champions of record on the date of closing of entries for the show;
- Individually registered with the American Kennel Club as of the date of closing of entries for the show;
- Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show.

The person handling the dog in this class must be a breeder of record and an owner of record of this dog.

In any subsequent classes for which the dog from the Bred-By-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

## NOTICE TO EXHIBITORS

**This dog show is being conducted in accordance with the rules and regulations of the American Kennel Club and the following additional rules and regulations that are referred to in the Official Entry Form to which you have subscribed and agreed to observe and perform. Any infraction of these rule and regulations is subject to a fine and/or suspension of your further participation in the show by the Show Committee.**

1. A \$3.00 service fee and a \$.50 recording fee will be required for each dog entered in regular classes at any Licensed or member club show. These fees are to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (American Kennel Club Rule, Chapter 11, Section 2).
2. Conditional, unsigned, incomplete, or entries received without the proper fee will not be accepted. Returned checks do not constitute payment of a valid entry fee. Subsequent returned checks from the same exhibitors will results in their being put on a cash only basis.
3. Exhibitors and their dogs should be at the show at least ½ hour before the scheduled judging time of their class. A schedule will be mailed to all of the exhibitors after closing of entries.
4. Owners are responsible for any errors in completing entry forms (whomever may make such errors) and no entry fees will be refunded in the event of such errors. Information on entry forms must be clear and legible. Please print legibly or type all information.
5. Entry fees shall not be refunded if a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by actions of the Show Committee.
6. Non-entered dogs will not be allowed at the Show.
7. Dogs may not be removed from the show before being judged except by consent of the Event Secretary or upon a Veterinarian's recommendation.
8. There shall be no drilling, intensive or abusive training of dogs on the show grounds or premises. No practice rings or areas shall be provided.
9. The owner or agent entering a dog in this Show does so at his own risk. The club will not be responsible for loss of, or damage to any dog exhibited. Every dog in this show is in the care, custody and control of his owner or handler the entire time the dog is on show premises. All dogs must be held on leash or confined to a crate except when being judged.
10. Entries must be in the hands of the Event Secretary by the closing date. Postmark on envelopes, time of mailing, post office errors, etc., are factors that cannot be taken into account in determining whether entries are "in" before the closing deadline.
11. The well-being of dogs and participants is of paramount importance to the AKC and the NSDCH. The NSDCH Show Committee will cancel the event if weather conditions such as hurricane, extreme wind, rain, or heat occur.

SCHEDULE OF POINTS FOR DIVISION 11  
EFFECTIVE MAY 7, 2008  
For complete Conformation Championship requirements see  
**Chapter 16** of the *Rules Applying to Dog Shows*

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of *both* sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its *own* sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.
