BRED-BY EXHIBITOR CLASS

*Please note the change in Rules and Regulations Applying to Dog Shows
(Chapter 3, Section 7) effective 9/18/02*

Section 7. The Person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-By Exhibitor class becomes eligible, there are no restrictions as to whom may handle.

JUNIOR SHOWMANSHIP CLASSES

NOVICE JUNIOR: For Boys and girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE: For Boys and girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR: For Boys and girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR: For Boys and girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE: For Boys and girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR: For Boys and girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three 1st places, with competition present, in a Novice Class at a licensed or member show.

SPECIAL EVENT

BEST BRED-BY EXHIBITOR GROUP COMPETITION

ELIGIBILITY: Dogs/bitches not defeated in the regular Bred-By Exhibitor class are eligible for Best Bred-By Exhibitor competition. Following the individual Breed (Variety) judging, a Best Bred-By Exhibitor in Breed (Variety) will be selected by the assigned Breed Judge from competition between the First Place regular Bred-By Exhibitor Dog Winner and the First Place Regular Bred-By Exhibitor Bitch Winner. The Best Bred-By Exhibitor in Breed (Variety) would then be eligible to compete in the Best Bred-By Exhibitor Group competition. If the winner of the Bred-By Exhibitor Class is not present for Best Bred-By Competition, a Second Place Dog may not compete in its place. In certain instances there will be an "Automatic" Best Bred-By Exhibitor in Breed or Group.

For example:

- A. An entry in the Bred-By Exhibitor class that is awarded Best of Breed or Best of Winners would automatically be the Best Bred-By Exhibitor in Breed.
- B. If a Bred-By Exhibitor class dog/bitch wins the regular Group first at the show prior to the Bred-By Exhibitor Group judging, the Bred-By Exhibitor Group will still be held for second, third and fourth places.

NOTICE TO EXHIBITORS

This dog show is being conducted in accordance with the rules and regulations of The American Kennel Club and the following additional rules and regulations that are referred to in the Official Entry Form to which you have subscribed and agreed to observe and perform. Any infraction of these rules and regulations is subject to a fine and/or suspension of our further participation in the show by the Show Committees.

No Entry will be accepted which specifies any condition as to its acceptance. Email, telegraph and unsigned entries cannot be accepted and will be returned. Entries not of Official AKC Entry Forms and Photocopies of Entry Forms with the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Show Secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent entered a class for which the dog is not eligible to compete.

THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.

Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the judge or Veterinarian, or barred from competition by action of the Show Committee or because it has been entered incorrectly. There will be a refund for Obedience minus the \$2.00 fees for bitches in season; bitches entered for breed competition are eligible to be shown. There is no refund for **DUPLICATE ENTRIES OR OVERPAYMENTS**. The Show Secretary will make every effort to find all Duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fee will be made.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Show Secretary will add a collection fee of \$20 to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on **CASH ONLY BASIS**.

REFUNDS for cancellations due to judge change, overpayment of entries or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW**.

JUDGING - Entries will be acknowledged after entries close with entry acknowledgement and judging program to address on entry. Should Exhibitor NOT receive an acknowledgement within a reasonable time, PLEASE notify the Show Secretary at the above address or telephone (808) 966-4813.

LOSS OR DAMAGE - The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in this show. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show. All persons attending his dog show hereby waive any claim from damages against the Tropical Toy Dog Fanciers of Hawaii, and its members, in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented condition.

TROPHIES - Trophies and prizes will be awarded at the Show to the person exhibiting the dog. No Award will be mailed.

NO FAXED OR CREDIT CARD ENTRIES WILL BE ACCEPTED BY THE CLUB.

JUNIOR SHOWMAN MUST BE AT LEAST 9 YEARS OF AGE AND UNDER 18 YEARS OF AGE ON THE DAY OF THE SHOW. By signing the entry form we certify that the Junior Showman does not now, and will not at anytime, act as an agent/handler for pay while continuing to compete in Junior Showmanship.

Private Exercise pens may be setup during the show hours of 8:00-5:00, at a location to be determined by the Grounds Committee.

SCHEDULE OF POINTS FOR DIVISION 11

EFFECTIVE MAY 7, 2008

For complete Conformation Championship requirements see

Chapter 16 of the *Rules Applying to Dog Shows*

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of *both* sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its *own* sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

THE YORKSHIRE TERRIER AKC Breed Standard

General Appearance

That of a long-haired toy terrier whose blue and tan coat is parted on the face and from the base of the skull to the end of the tail and hangs evenly and quite straight down each side of body. The body is neat, compact and well proportioned. The dog's high head carriage and confident manner should give the appearance of vigor and self-importance.

Head

Small and rather flat on top, the **skull** not too prominent or round, the **muzzle** not too long, with the **bite** neither undershot nor overshot and teeth sound. Either scissors bite or level bite is acceptable. The **nose** is black. **Eyes** are medium in size and not too prominent; dark in color and sparkling with a sharp, intelligent expression. Eye rims are dark. Ears are small, V-shaped, carried erect and set not too far apart.

Body

Well proportioned and very compact. The back is rather short, the back line level, with height at shoulder the same as at the rump.

Legs and Feet

Forelegs should be straight, elbows neither in nor out. **Hind legs** straight when viewed from behind, but stifles are moderately bent when viewed from the sides. **Feet** are round with black toenails. Dewclaws, if any, are generally removed from the hind legs. Dewclaws on the forelegs may be removed.

Tail

Docked to a medium length and carried slightly higher than the level of the back.

Coat

Quality, texture and quantity of coat are of prime importance. Hair is glossy, fine and silky in texture. Coat on the body is moderately long and perfectly straight (not wavy). It may be trimmed to floor length to give ease of movement and a neater appearance, if desired. The fall on the head is long, tied with one bow in center of head or parted in the middle and tied with two bows. Hair on muzzle is very long. Hair should be trimmed short on tips of ears and may be trimmed on feet to give them a neat appearance.

Colors

Puppies are born black and tan and are normally darker in body color, showing an intermingling of black hair in the tan until they are matured. Color of hair on body and richness of tan on head and legs are of prime importance in adult dogs, to which the following color requirements apply:

Blue: Is a dark steel-blue, not a silver-blue and not mingled with fawn, bronzy or black hairs.

Tan: All tan hair is darker at the roots than in the middle, shading to still lighter tan at the tips. There should be no sooty or black hair intermingled with any of the tan.

Color on Body

The blue extends over the body from back of neck to root of tail. Hair on tail is a darker blue, especially at end of tail.

Headfall

A rich golden tan, deeper in color at sides of head, at ear roots and on the muzzle, with ears a deep rich tan. Tan color should not extend down on back of neck.

Chest and Legs

A bright, rich tan, not extending above the elbow on the forelegs nor above the stifle on the hind legs.

Weight

Must not exceed seven pounds.

Disqualifications:

Any solid color or combination of colors other than blue and tan as described above. Any white markings other than a small white spot on the forechest that does not exceed 1 inch at its longest dimension.
