BRED BY EXHIBITOR (BBE) Class Eligibility (Revised 9/02)

Effective 9/02, the Bred By Exhibitor class shall be for dogs that are:

- Six months of age or older as of the first day of the show;
- Not champions of record on the date of closing of entries for the show;
- Individually registered with the American Kennel Club as of the date of closing of entries for the show;
- Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show.

The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred By Exhibitor class becomes eligible, there are no restrictions as to who may handle the dog.

SPECIAL ATTRACTION

BEST BRED BY EXHIBITOR IN SHOW COMPETITION

- Dogs and Bitches in the Bred By Exhibitor class are eligible for the Special Attraction Best Bred By Exhibitor in Group Competition.
- This class will be divided by sex. The winner of each bred by exhibitor class (dog and bitch) would then compete for Best of Breed Bred By Exhibitor. Only dogs that are not defeated in a bred by exhibitor class are eligible for Best Bred By Exhibitor competition.
- In certain instances there will be an automatic "Best Bred By Exhibitor" in the Breed or Group. For example: an entry in the regular Bred By Exhibitor class that is awarded Best of Breed or Best of Winners would automatically be Best Bred By Exhibitor in Breed.

Entry form **MUST** be filled out with the necessary information, otherwise the entry in Junior Showmanship will not be accepted.

NOVICE JUNIOR CLASS – For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS – For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS – For Boys and Girls who are at least 15 and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS – For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE CLASS – For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS – For Boys and Girls who are at least 15 and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

LOSS OR DAMAGE

The Trial Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in this trial.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restrain over their children on the day of the shows.

All persons attending these shows hereby waive any claim from damages against the Working Dog Club of Hawaii or its members, in the event a motor vehicle has to be entered to rescue a dog from overheating for improperly vented conditions.

NOTICE TO EXHIBITORS

This dog show is being conducted in accordance with the rules and regulations of the American Kennel Club and the following additional rules and regulations that are referred to in the Official Entry Form to which you have subscribed and agreed to observe and perform. Any infraction of these rules and regulations is subject to a fine and/or suspension of your further participation in the show by the Show Committee.

ENTRIES CLOSE Wednesday, October 1, 2008 at 12:00 Noon, in the office of the Show Secretary after which time entries cannot be accepted, cancelled, altered or substituted except as provided for in Chapter 11, Section 6, of the Dog Show Rules. Conditional, unsigned, incomplete, telephone or facsimile and telegraph entries cannot be accepted.

ENTRIES NOT ON OFFICIAL AKC FORMS or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

CHANGES, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Changes which are received on the telephone are unacceptable.

OWNERS ARE RESPONSIBLE FOR ERRORS on entry blanks, for entering the same dog twice, or for entering a dog in a class for which it is ineligible to compete, regardless of who makes such errors.

ENTRY FEES WILL NOT BE REFUNDED in events of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, in season, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. If because of riots, civil disturbances, fire, Act of God, act of a public enemy, strikes, or any other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fee(s) will be made.

CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME will be sent to the address on the Official AKC entry form after closing date. If an exhibitor has not received a copy of the Schedule within seven days of the show, contact the Show Secretary.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY. A collection fee of \$20 will be added to the amount of the returned check. Subsequent returned checks from the same exhibitor(s) may result in their being put on a CASH ONLY basis.

PLEASE NOTE: Effective for all shows held on or after July 1, 1980, dogs which according to their owners records have completed the requirements for a championship after the closing the entries for the show but whose championships are unconfirmed may be transferred from one of the regular classes to Best of Breed or Variety competition, provided that transfer is made by the Show Secretary one half hour prior to the start of any regular conformation or obedience judging at the show. (AKC Rules, Chapter 11, Section 6)

DOGS MUST BE AT THE SHOW only at scheduled time of judging and may leave immediately after unless required for further judging.

DOGS MUST BE READY FOR JUDGING. The Club and/or its Show Secretary will not be responsible for and are not obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges will not wait for any dog holding up a class. Owners or their agents alone are responsible for the presence of their dogs in the judging ring.

THE SHOW GIVING CLUB, SHOW SECRETARY, their agents or employees assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property and further assumes no responsibility for injury to any child not under control of parents or guardians.

NO DOGS WILL BE ALLOWED IN THE SHOW AREA except those regularly entered in the show. There will be NO space for unentered dogs at this show.

ALL TROPHIES shall be claimed on the day of the show – None will be mailed.

THE CLUB has the right to offer alternate trophies of equal value if it becomes necessary.

THERE SHALL BE NO DRILLING nor extensive or abusive training of dogs on the show grounds or premises. All dogs should be kept on leash except when in the obedience ring.

Exhibitors should follow their veterinarians' recommendations to assure that their dogs are free of internal and external parasites, any communicable diseases, and have received all appropriate vaccinations.

SCHEDULE OF POINTS FOR DIVISION 11
EFFECTIVE MAY 7, 2008
For complete Conformation Championship requirements see
Chapter 16 of the *Rules Applying to Dog Shows*

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of *both* sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its *own* sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.
