Rally Classes: Novice A and B, Advanced A and B, Excellent A and B

Non Regular: Pairs Novice, Pairs Advanced, Challenge

NOTE REGARDING NON-REGULAR OBEDIENCE CLASSES

The Rules and Regulations for *Graduate Novice, Graduate Open, Brace & Veterans Novice* are contained in the AKC Obedience Regulations. The following rules shall apply to Veterans Open and Veterans Utility.

VETERANS OPEN: The dog must be 7 years or older and have a CDX title. The exercises and rules for judging and scoring are identical to those for the Open B classes, except that the handler may elect to jump ½ of the dogs regulation jump height.

VETERANS UTILITY: The dog must be 7 years or older and have a UD title. The exercises and rules for judging and scoring are identical to those for the Utility B Class, except that the handler may elect to jump ½ of the dog's regulation jump height.

NOTE REGARDING NON-REGULAR RALLY CLASSES

The Rules and Regulations for *Rally Pairs (Novice) and Rally Pairs (Advanced)* are contained in the AKC Rally Regulations. The following rules shall apply to Rally Challenge class.

RALLY CHALLENGE: This class will consist of 10 to 15 Rally Novice exercises that are consecutively numbered (including the finish sign), except for Start. Handlers entered are not allowed to see or walk the course prior to entering the ring for their turn. This class will be judged and scored as in the Rally Novice class. All exercises are performed on leash. In the event of a tie for placements, time will be used as a tiebreaker. Entries are limited to one entry per Exhibitor in this class.

MOVE-UPS IN BOTH RALLY AND OBEDIENCE CLASS WILL BE ALLOWED AT THIS TRIAL IN ACCORDANCE WITH AMERICAN KENNEL CLUB OBEDIENCE REGULATIONS (Chapter 1, Section 16a).

* * * * NOTICE TO EXHIBITORS * * * *

1. A recording fee of \$.50 on the first entry only, and an event service fee of \$3.00 for each entry will be required at any Licensed or Member Club Show and Obedience or Rally Trial. These fees are to be collected by the show giving club and paid to the American Kennel Club. There is no recording fee or event service fee for Non-Regular Obedience and Non Regular Rally classes.
2. **CONDITIONAL, UNSIGNED, INCOMPLETE, OR ENTRIES RECEIVED WITHOUT FEES WILL NOT BE ACCEPTED.**
3. Exhibitors and their dogs should be at the Obedience or Rally Trial at least ½ hour before the scheduled judging time of their class. A schedule will be mailed to all of the exhibitors after closing of entries. Please advise your ring steward if you anticipate any conflicts running your dog(s) in this Trial.
4. Owners are responsible for any errors in making out entry forms (whom-ever may make such errors) and no entry fee will be refunded in the event of such errors. Information on the entry forms must be clear and legible.
PLEASE PRINT LEGIBLY OR TYPE ALL INFORMATION WHEN COMPLETING THE ENTRY FORM.
5. Entry fees shall not be refunded if a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by action of the Obedience Trial Committee.

EXCEPTION: Refund of entry fee will be made if a female dog “comes in season” before the date of the Obedience Trial, provided the request for the refund is received by the Trial Secretary at least ½ hour before the start of the class that the dog is entered in at the Trial. 100% of the entry fee will be refunded – the \$.50 AKC recording fee and the \$3.00 event service fee WILL NOT be refunded to the exhibitor.

6. Dogs may not be removed from the obedience or rally trial before being judged except by consent of the Trial Secretary or upon a veterinarian’s recommendation.
7. Dogs not required for further judging will be excused.
8. **UNENTERED DOGS WILL NOT BE ALLOWED AT THE OBEDIENCE TRIAL.**
9. **THERE SHALL BE NO DRILLING, INTENSIVE OR ABUSIVE TRAINING OF DOGS ON THE SHOW GROUNDS OR PREMISES. NO PRACTICE RINGS OR AREAS SHALL BE PERMITTED.** (AKC Obedience Regulations, Chapter 2, Section 26.)
10. The owner or agent entering a dog in the Obedience or Rally Trial does so at his own risk. The Club WILL NOT BE RESPONSIBLE for loss of, or damage to, any dog exhibited. Every dog in the Obedience Trial is in the care, custody and control of his owner or handler during the entire time the dog is on the Obedience Trial premises.
ALL DOGS MUST BE HELD ON LEASH OR CONFINED TO A CRATE EXCEPT WHEN BEING JUDGED.
11. In order to be eligible for a trophy, exhibitors or their agents must stay until the trophy is awarded. The agent must present the exhibitor’s armband.
12. **EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS’ RECOMMENDATION TO ASSURE THEIR DOGS ARE FREE OF INTERNAL AND EXTERNAL PARASITES, ANY COMMUNICABLE DISEASES, AND HAVE APPROPRIATE VACCINATIONS.**

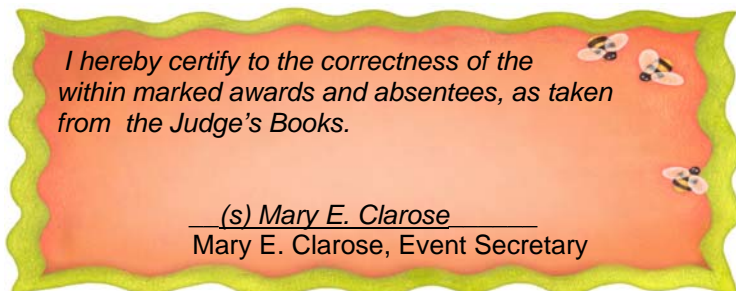
