**Obedience Classes:** Novice A and B, Open A and B, Utility A and B, Graduate Novice, Graduate Open, Versatility. **Obedience Classes (Non Regular):** Brace, Veterans (Novice, Open, Utility)

**Rally Classes:** Novice A and B, Advanced A and B, Excellent A and B. **Rally Classes (Non Regular):** Rally Pairs (Novice, Advanced), Challenge

### NOTE REGARDING NON-REGULAR OBEDIENCE CLASSES

**VETERANS OPEN:** The dog must be 7 years or older and have a CDX title. The exercises and rules for judging and scoring are identical to those for the Open B classes, except that the handler may elect to jump ½ of the dogs regulation jump height.

**VETERANS UTILITY:** The dog must be 7 years or older and have a UD title. The exercises and rules for judging and scoring are identical to those for the Utility B Class, except that the handler may elect to jump ½ of the dog's regulation jump height.

### NOTE REGARDING NON-REGULAR RALLY CLASSES

The Rules and Regulations for *Rally Pairs (Novice)* and *Rally Pairs (Advanced)* are contained in the AKC Rally Regulations. The following rules shall apply to Rally Challenge class.

**RALLY CHALLENGE:** The Rally Challenge class will consist of 15-20 stations selected from Regular and Non-Regular signs except #34 & #50. All exercises are performed on leash. There will be no published map or walk through. Handlers will be sequestered until their turn. Each competitor may only enter one dog in this class. Scores will be based on the Rally regulations for scoring with a maximum 100 points. In the event of a tie for placements, time will be used as a tiebreaker.

## **TRACKING DOG TEST RULES**

Entries will be accepted up until the official closing date even though the advertised limit has been reached. A drawing will be held to determine which dogs will participate in the Tests.

Entries will be drawn by the Test Secretary and the drawing will be random among all entries received EXCEPT that preference shall be given to those dogs which have not previously earned a Title.

With an entry form for a dog that has not passed an AKC Tracking Dog Test, there must be filed an original statement certifying that the dog is considered to be ready for the Tracking Dog Test. This statement, dated within one year, must be signed by a person who has been approved by the American Kennel Club to judge Tracking Tests.

Tracking Dog Test will begin promptly at 6:00 AM. The drawing for the running of the dogs will be at 6:20 AM at the Moanalua Intermediate School parking lot. First track will be run at 6:30 AM.

Entries are limited to 2 entries for the Tracking Dog Test.

In the event more than the above-stated entries are received for this Test, the drawing will be held on SUNDAY, August 8, 2010, at 9:45 AM at Thomas Square, Honolulu, HI. The Test Secretary shall notify all entries of the results of the drawing.

When the advertised limit has been drawn, all remaining entries, subject to the same preference set forth in the preceding paragraphs, shall be assigned a position on an alternate list corresponding to the order in which they were drawn.

Following the drawing, the Test Secretary shall promptly contact all entrants and advise them of the outcome. Alternates shall be given the option to accept or decline being placed on the alternate list. Those who accept shall be placed on the alternate list in the order in which they were drawn. Those who opt to decline shall have their Entry Fees (and certificates) returned. Entrants and alternates who are not given the opportunity to run a track shall have their Entry Fees, less recording fee (and certificates), returned.

The complete list of alternates, and whether they accepted or declined, is to be included with the Test Report which is sent to the American Kennel Club following the Test. In the event an accepted entry is absent on the day of the Test, it shall be the responsibility of the Test Secretary to determine whether any alternates are present corresponding to the order in which they were drawn.

**BITCHES IN SEASON MAY PARTICIPATE.** Bitches in season will be allowed to participate in a test only after all the other dogs, and bitches not in season, have been tested.
